Behavior

Social Membership at The Landing - Woodson YMCA is a privilege. The Woodson YMCA, to the extent not otherwise prohibited by applicable law, reserves the right to deny, condition, or revoke membership of any individual who:

- (i) is arrested for, charged with, or convicted of sex offenses as that term is defined in Wis. Stat. §301.45(1d)(b);
- (ii) is arrested for, charged with, or convicted of other crimes inconsistent with the values of the YMCA, including crimes involving moral turpitude or bodily harm; or
- (iii) engages in inappropriate behavior, or other misconduct on or near the property of the YMCA, including, but not limited to, profanity, abusive language, inappropriate attire, smoking, consumption of alcohol, or removal or damage of YMCA property.
- The YMCA conducts regular sex offender screenings on all members, participants, and guests. If a sex offender match occurs, the YMCA reserves the right to cancel membership, end program participation, and remove visitation access.

Policies

I understand that if I wish to cancel, I will provide a 30-day notice by either completing a cancellation form or by mailing in a cancellation letter. Cancellations via phone are not accepted.

FOR VALUE RECEIVED, I, the undersigned authorize the financial institution, designated hereon to pay to the YMCA and charge to the account(s) identified on the attached deposit slip(s) on a monthly basis, any amount that comes due for the particular membership to which I have agreed with the YMCA, charges to my account(s), shall be in the amount stated on electronic funds transfer authorization form statement (or other written statement) received by you from the YMCA. Your rights in respect to each deduction shall be the same as if the written statement issued by the YMCA were a check drawn on you personally signed by me. You are authorized to rely on electronic transfer statement (or other written statement) received by you from the YMCA.

I understand that the Woodson YMCA submits the auto deduction information on the 20th of every month. If I have my membership dues taken from a checking or savings account, I understand that payment will typically settle in my account between the 21st and 23rd of the month. If I am paying via credit card or debit card, I understand that my credit card or debit card will be charged on the 20th of the month. The deduction that occurs on the 20th of every month pays for the first day of the month through the last day of the month. I understand that my membership is ongoing and if I wish to terminate my membership, I must give the YMCA a written notice by filling out a cancellation form or sending a cancellation letter. I understand that the Woodson YMCA requires a 30 day notice to cancel and that the month I complete the written cancellation will be the last month that I am charged for my membership dues. If I need to make a change to my membership or account information, I understand that I must complete a change form by the 15th of the month.

I understand that the YMCA Board of Directors, at its discretion, may adjust the monthly rate applicable to my category of membership. I understand that I will receive at least 4 weeks notice prior to any such change in rate.

If any payments requested by the YMCA pursuant to an electronic fund transfer statement (or other written statement) submitted to my bank is not honored by my bank for any reason, I realize that I am still responsible for the payment plus any services charges applied by or charged to the YMCA. I authorize the YMCA to issue additional statements to my bank to collect any such delinquent payment together with any service charges applied by or charged to the YMCA. This is in addition to any service charge my bank may make.

I agree to indemnify, defend and hold harmless the Woodson YMCA including the Wausau and Aspirus branches from and against any and all loss, liability, or expense on account of or related to any action or inactions of the YMCA or arising from the use of the YMCA.
